PUBLICATION MALPRACTICE STATEMENT

The **Journal of Economics, Management & Agricultural Development (JEMAD)**, with ISSN No. **2546-101X** (*Online*) and ISSN No. **2546-1001** (*Print*), is an open access peer-reviewed Journal, publishes biannually by the College of Economics and Management of the University of the Philippines Los Baños (CEM-UPLB), upholds the standards of Journal Publication Ethics and adheres to the Code of Conduct and Best Practice Guidelines for Journals Editors of the Committee on Publication Ethics (COPE). The following sections are JEMAD's Publication Ethics and Malpractice Statements.

Open Access Statement

JEMAD is an open access Journal and applies Creative Commons Attribution-NonCommercial-ShareAlike 4.0 License (<https://creativecommons.org/licenses/by-nc-sa/4.0/>), which permits non-commercial use, reproduction, and distribution of the work without further permission provided the original work is attributed. All authors publishing in JEMAD accepts this license agreement as part of the terms of publication.

RESPONSIBILITIES OF THE EDITOR-IN-CHIEF AND EDITORIAL BOARD OF JEMAD

Publication decisions

After a diligent peer review process, the Editor-in-Chief (EIC) makes the final decision of accepting or rejecting a manuscript for publication. The EIC's final evaluation is solely based on the paper's significance, originality, rigor, clarity of the study, and relevance to the JEMAD's scope and themes. Current legal codes for libel, copyright infringement, and plagiarism are also considered.

Confidentiality

JEMAD implements a double-blind peer review process. The Editor-in-Chief, Managing Editor, Editorial Assistants, and Editorial Staff must not disclose details about a submitted manuscript to anyone outside of the Journal Management Team. JEMAD staff shall ensure that the manuscripts undergo a fair and unbiased double-blind peer review process. All information about the author, peer reviewers, and the result of the peer review process shall be confidential. JEMAD shall ensure that authors' and peer reviewers' identities are protected and appropriate referees/peer reviewers for the manuscript are selected.

Disclosure and conflicts of interest

The Editor-in-Chief and Editorial Board Members are prohibited, for any purpose, to use unpublished materials disclosed as part of a submitted manuscript to JEMAD without the author's written consent.

REFEREE/PEER REVIEWER'S RESPONSIBILITIES

Contribution to editorial decisions

The Referee/Peer Reviewer shall assist the Editor-in-Chief and Editorial Board Members of JEMAD in reviewing submitted manuscripts to improve their content and assist in editorial decisions related to the potential publication of the manuscript.

Promptness

Should any invited Referee/Peer Reviewer believe that he/she is not qualified to review the manuscript or would be unable to submit the feedback on the date requested by JEMAD, the Referee/Reviewer shall notify the Editor-in-Chief. Referees/Peer Reviewers may withdraw from the review process and recommend alternative and equally competent Referees/Peer Reviewers.

Confidentiality during the Review Process

JEMAD shall treat all submitted manuscripts undergoing the review process with confidentiality. The confidentiality of any privileged information or ideas obtained through the peer review process is strictly observed. Hence, the Referee/Peer Reviewer and JEMAD staff involved in facilitating the review process is prohibited to disclose this information to anyone.

Standards of objectivity

The Referees/Peer Reviewers should conduct reviews objectively and state observations explicitly with supporting arguments to assist the Authors in improving their manuscripts. They should assess the submitted manuscripts based on content, rigor, originality, and relevance to JEMAD themes. It is considered inappropriate and unprofessional to criticize the author personally.

Acknowledgment of sources

They should indicate, whenever appropriate, whether observations or arguments from other publications accompany the appropriate source.

Should there be any observed copyright infringement and plagiarism, the Referees/Peer Reviewers must notify the Editor-in-Chief in writing.

Disclosure and conflict of interest

Referees/Peer Reviewers should not assess manuscripts in which they have a conflict of interest deriving from competitive, collaborative, or other relationships or connections involving any of the authors, companies, or institutions associated with the manuscripts. Referees/Reviewers should inform the Editor-in-Chief, in writing, if they deem they face a conflict of interest in the review process.

AUTHOR'S DUTIES

Reporting standards

Authors of original research reports should provide an accurate account of the work performed and objectively discuss its significance. They should accurately present the underlying data from which the paper is based. A paper should include sufficient detail and references to allow others to replicate the work. Fraudulent or knowingly inaccurate statements are unethical and unacceptable.

Data access and retention

Authors may be asked by JEMAD to submit the raw data from their study in addition to the paper for the editorial and peer review process. If called to, they should be prepared to make the data publicly available.

Authors should ensure accessibility of such data to other competent professionals for at least ten years after publication (preferably via an institutional or subject-based data repository or other data center), provided that the confidentiality of the participants can be protected and legal rights concerning proprietary data do not preclude their release.

Originality, plagiarism, and acknowledgment of sources

Authors shall submit to JEMAD completed original works with proper citations from different studies (i.e., direct quotation etc). Published works and/or studies which influenced the submitted manuscript shall be included in the Reference section.

Authors shall, in writing, confirm that the submitted work is originally owned by the Author and has not been copied or plagiarized in whole or in part from other works without attributing or quoting the source.

Multiple, redundant, or concurrent publication

Manuscripts that are currently under the JEMAD's peer review process are prohibited to be concurrently submitted to other copyrighted publications unless the author withdraws their manuscript from the review process. However, by submitting a manuscript, the author(s) retain the rights to the unpublished manuscript under review. In case of publication, they permit the use of their work under a CC-BY license [<http://creativecommons.org/licenses/by/3.0/>], which allows others to copy, distribute and transmit the work as well as to adapt the work and to make commercial use of it. In addition, Published Manuscripts with copyright elsewhere shall not be accepted by JEMAD.

Authorship of the paper

Authorship should be limited to those who have actively participated in the development of the manuscript and, thus, have done any of the following:

- provided a significant contribution to the conception, design, data collection, or interpretation of the reported study;
- wrote or critically revised the study; and
- approved its final submitted version and agreed to be accountable for all aspects of the work.

Main authors should ensure that only co-authors, who contributed in these ways to develop the article, be included. Moreover, the corresponding author ensures that all contributing co-authors are acknowledged in the list of authors and that no uninvolved individuals are included. It is also the corresponding author's responsibility to ensure that all co-authors have authorized the final version of the paper and agreed to its submission.

Disclosure and conflicts of interest

All authors should include statements disclosing any financial or other substantive conflicts of interest that could be interpreted as influencing the results or interpretation of their manuscript. They should disclose all financial support that helped in the development and completion of the manuscript.

Fundamental errors in published works

In the event that JEMAD finds a significant error or inaccuracy in the Author's work after publication, the Author should communicate with and work cooperatively with the JEMAD Editorial Assistants and Staff should there be a need for the published paper to be retracted or updated with an erratum.

PUBLISHER'S RESPONSIBILITIES

As publisher of JEMAD, the College of Economics and Management (CEM) shall:

- provide assistance to the JEMAD Editor-in-Chief and Editorial Board to adhere to the COPE Code of Conduct for Journal;
- ensure autonomy in Editorial and production decisions;
- secure copyright and intellectual property rights; and
- ensure that JEMAD upholds the standards and best practices declared by the Journal.
